### China Trade Balance with the World

China, in 2021, registered a trade surplus of USD 679 billion, having increased USD 258 billion compared to 2017 and USD 142 billion compared to 2020.

### **China Trade Balance with Portugal**

China was the 14<sup>th</sup> customer of Portuguese exports of goods in 2021, with a share of 1.1% in total, occupying the 6<sup>th</sup> position in terms of imports (4.7%). Over the period 2017-2021 there was an average annual decrease in exports of 3.9% and a growth of 17.7% in imports. The balance of trade in goods was unfavorable to Portugal, having presented a deficit of 3 205 million euros in 2021.

Portuguese Prime Minister António Costa said, during the opening ceremony of Macao Forum, that *Portugal wants more cooperation with China*.


